# COACH OF THE YEAR AWARD 2022 NOMINATION PACKAGE

The Coaching Association of Canada presents the Coach of the Year Award in recognition of the outstanding achievements of a coach in Canada, both for the sport performances of their athlete(s) or team in the previous high-performance competitive season and for exhibiting excellence in sport values.

The recipient of this award guides their athletes to success in sport and in life by instilling in them the values of honesty, integrity, a positive attitude, competitiveness, and a love of sport. This coach leads by example and consistently demonstrates a dedication to lifelong learning and continuous improvement.

## Eligibility requirements:

To be eligible to receive the Coach of the Year Award, a coach must meet the following requirements:

- Be an NCCP Certified coach with Competition Development certification or higher and have coached for a minimum of 5 years or have an equivalent level of coaching education and experience, as determined by the Award Selection Committee
- Have worked closely with an athlete or team from Canada that achieved an outstanding performance at an international event in the previous high-performance competitive season (i.e Olympic and Paralympic Games, World Championships, PanAmerican and Para PanAmerican Games, CommonWealth Games etc.)
- Have demonstrated the characteristics of honesty, integrity, a positive attitude, competitiveness, and a love of sport
- Have demonstrated commitment to the core principles of the NCCP Code of Ethics: Leadership and professionalism, health and safety, and respect and integrity
- Have shown care for the holistic development of the athlete
- Have been a positive role model and mentor for colleagues and peers
- Have demonstrated a commitment to lifelong learning
- Have presented an ethical and positive public image

## Selection process:

The CAC Awards Committee will review all nominations put forward by the deadline.

If successful, both the nominator and recipient will be contacted by the CAC. If unsuccessful, only the nominator will be sent a letter of decision.

The Coaching Association of Canada is committed to promoting the values of diversity and inclusion and recognizes the tremendous contribution that all coaches make to the sport system in Canada and to the success of athletes on and off the field of play.
