## Coaching Association of Canada (CAC) Task Force – Terms of Reference for the International Coach Training eLearning module + Enhanced Screening Project

Background	In May 2023, Sport Canada provided additional funding to the CAC to develop an eLearning module to support the sport community and specifically the integration of international Coaches working with Canadian National teams in Canada. A promotional and marketing toolkit will also be developed to support sport organizations to contract and onboard international coaches to coach in Canada, or for National teams while based out of country (example: Europe). The eLearning module will provide an effective onboarding process for National Team coaches to their programming in the Canadian context, including values, ethics, and coaching expectations. Furthermore, the CAC received funding to develop, pilot and finalize enhanced coaching screening criteria that can be applied through the Canadian sport system (National team, provincial-territorial, club, post-secondary, etc).		
Purpose & Mandate	The Task Force is to provide guidance, expertise, experience to develop the eLearning module to support the integration of international coaches into the sport system in Canada. In addition, the task force will provide advice and guidance on the Enhanced screening process and CAC Professional coach designation and servicesfor new, current and international coaches coaching in National and development team programs.

Roles & Responsibilities	The role of the Task Force is to review and develop content for the module and provide advice, content recommendations, and feedback to the CAC and its instructional designers based upon current research and partner needs. As well, the Task Force will provide guidance and recommendations on standards of practice for screening of coaches as well as the standards of the professional designation.  Specific Task Force responsibilities include:  Review of background documents (to be provided by CAC)  Provide content recommendations to the CAC for the eLearning module  Recommend additional expertise to develop content

Resources	The Coaching Association of Canada will provide resources as are necessary to ensure the successful completion of this project in a timely manner.	
Timelines	The Task Force will commence in August 2023 with a virtual introduction meeting, followed by a 2-day, in-person meeting the week of September 11, 2023, and follow-up virtual meetings to review story board and processes. The task force will fulfill all duties by March 31, 2024. A detailed action plan with estimated timelines are outlined in Annex 1 and Annex 2.
