### About the relaunch of NCCP Sport Nutrition and NCCP Emergency Action Plan eLearning Module

- The CAC is planning to relaunch these modules with little to no content updates.
- The emphasis will be on confirming the accessibility standards for both modules as described below and ensuring the output files meet these standards.
- Original/existing source files will be supplied, mostly in HTML format.
- There are English and French modules for both titles.
- The eLearning modules are to be housed on and accessed via the CAC's Learning Management System (LMS).
- The eLearning modules must be completed, approved and delivered by February 2, 2024.

#### **Project Scope**

The eLearning module must be relaunched in English and French. Any required French translation will be provided to the successful developer. Other considerations include:

- The successful developer must be available between the project start date and February 2, 2024.
- The successful developer will have access to the Project Manager and the CAC eLearning Lead.
- All content will be provided to the developer by October 18, 2023. See "Project Timeline" below.

- Experience and background
- Pricing profile for all aspects of the project
- Hourly rate for subsequent work
- Samples of previous work, unless previously submitted, and
- Contact information for 2 References, unless previously submitted

All fees must be itemized to include an explanation of all fees. Contract terms and conditions will be negotiated upon the selection of the winning bidder for this RFP. All contractual terms and conditions will be subject to review by the CAC and will include scope, budget, schedule, and other necessary items pertaining to the project.

#### **Deadline for Submission**
